Same Sex Couples - Comparative Insights on Marriage and Cohabitation Macarena Sáez, 2015-05-06 This book shows six different realities of same-sex families. They range from full recognition of same-sex marriage to full invisibility of gay and lesbian individuals and their families. The broad spectrum of experiences presented in this book share some commonalities: in all of them legal scholars and civil society are moving legal boundaries or thinking of spaces within rigid legal systems for same-sex families to function. In all of them there have been legal claims to recognize the existence of same-sex families. The difference between them lies in the response of courts. Regardless of the type of legal system, when courts have viewed claims of same-sex couples and their families as problems of individual rights, they have responded with a constitutional narrative protecting same-sex couples and their families. When courts respond to these claims with rigid concepts of what a family is and what marriage is as if legal concepts were unmodifiable, same-sex couples have remained outside the protection of the law. Until forty years ago marriage was the only union considered legitimate to form a family. Today more than 30 countries have granted rights to same sex couples, including several that have opened up marriage to couples of the same sex. Every day there is a new bill being discussed or a new claim being brought to courts seeking formal recognition of same sex couples. Not all countries are open to changing their legal structures to accommodate same-sex couples, but even those with no visible changes are witnessing new voices in their communities challenging the status quo and envisioning more flexible legal systems.

From the Closet to the Altar Michael Klarman, 2013 Bancroft Prize-winning historian and legal expert Michael Klarman here offers an illuminating and engaging account of modern litigation over same-sex marriage. After looking at the treatment of gays in the decades after World War II and the birth of the modern gay rights movement with the Stonewall Rebellion in 1969, Klarman describes the key legal cases involving gay marriage and the dramatic political backlashes they ignited. He

examines the Hawaii Supreme Court's ruling in 1993, which sparked a vast political backlash--with more than 35 states and Congress enacting defense-of-marriage acts--and the Massachusetts decision in Goodridge in 2003, which inspired more than 25 states to adopt constitutional bans on same-sex marriage. Klarman traces this same pattern--court victory followed by dramatic backlash--through cases in Vermont, California, and Iowa, taking the story right up to the present. He also describes some of the collateral political damage caused by court decisions in favor of gay marriage--Iowa judges losing their jobs, Senator Majority Leader Tom Daschle losing his seat, and the possibly dispositive impact of gay marriage on the 2004 presidential election. But Klarman also notes several ways in which litigation has accelerated the coming of same-sex marriage: forcing people to discuss the issue, raising the hopes and expectations of gay activists, and making other reforms like civil unions seem more moderate by comparison. In the end, Klarman discusses how gay marriage is likely to evolve in the future, predicts how the U.S. Supreme Court might ultimately resolve the issue, and assesses the costs and benefits of activists' pursuing social reforms such as gay marriage through the courts--

The Supreme Court's recent decision in *United States v. Windsor* striking down a crucial section of the Defense of Marriage Act means that validly married same-sex couples are now entitled to the federal benefits associated with marriage. Subsequent decisions by various administrative agencies have construed entitlement to such benefits broadly, so that even couples whose marriage is not recognized in their state of residence can claim several important benefits, including the right to sponsor their spouses into the country for immigration purposes, and the right to file joint income tax returns. These rights, though, have not been extended to couples who are in civil unions. Even though civil unions were created as a way for same-sex couples to approximate marriage at the state level, it now appears that those in civil unions will not be able to gain the federal benefits of marriage. Thus, it is likely that states that currently recognize civil unions will soon switch to full marriage equality, and it is likely that no states will be added to the civil union roster. But the civil union has been transformed into something different in three states (Illinois, Colorado, and Hawaii), because the right to enter into these unions has been extended to opposite-sex couples, as well. Since those in opposite-sex relationships chose civil unions over marriage, it is likely that these states will continue to allow the civil union option for both opposite- and same-sex couples. This Essay explores what the continuing presence of civil unions in a few states is likely to mean in the ongoing national discussion about the structure and legal support for various types of families.
