Sie geht ausführlich auf die derzeitige Rechtslage in Deutschland ein. Hierbei werden insbesondere auch vermeintliche Alternativen zur Präimplantationsdiagnostik untersucht und strafrechtlich bewertet. Auch die rechtliche Behandlung der Präimplantationsdiagnostik in Italien findet Berücksichtigung, wobei insbesondere das im Februar 2004 in Kraft getretene Gesetz zur Regelung der technisch assistierten Fortpflanzung sowie die einschlägige Rechtsprechung analysiert werden. Vor dem Hintergrund der italienischen Regelung und der damit verbundenen praktischen Erfahrungen werden Anregungen auch für die deutsche Gesetzgebung formuliert und aufgezeigt, dass angesichts der herrschenden Rechtsunsicherheit eine explizite Regelung fortpflanzungsmedizinischer Methoden, insbesondere der Präimplantationsdiagnostik, unabdingbar ist.

In sum, this book not only illustrates the historically significant and defining features of the music, but also links the surviving repertory to the flourishing musical culture in which it was created.
