Wahrnehmen, Speichern, Erinnern Bettina Gockel, Miriam Volmert, 2017-12-04 Gegenwärtige Entwicklungen in der digitalen Organisation von Wissen geben in den Geisteswissenschaften Anlass zu einer vertieften Auseinandersetzung mit der Geschichte kultureller Praktiken des Speicherns und Erinnerns. Der vorliegende interdisziplinäre Sammelband öffnet aktuelle Forschungsfragen zu historischen Theorien und Praktiken der Informationsverarbeitung für die Kunstgeschichtsforschung. Die Beiträge untersuchen anhand von Fallbeispielen des ausgehenden 17. bis frühen 19. Jahrhunderts, wie in einer Scharnierzeit konkurrierender Gedächtnisdiskurse neue Ideen der Wissensspeicherung und Erinnerungsverarbeitung in den Bildkünsten und der Kunsttheorie Europas reflektiert werden.

Petrarca und die bildenden Künste Maria Antonietta Terzoli, Sebastian Schütze, 2021-05-10 Petrarca hat sich intensiv mit den bildenden Künsten seiner Zeit auseinandergesetzt. Er besaß ein Madonnenbild Giotto's und beauftragte Simone Martini mit dem einzigartigen Frontispiz seines Vergilcodex. Seine Werke sind Schlüsseltexte für die Entdeckung der Landschaft und die humanistische Villenkultur ebenso wie für das weibliche Porträt und die Triumphikonographie der Renaissance und des Barock. Der mit Petrarca verbundene Mythos des Dichterstürzen bietet bis in die Moderne hinein eine produktive Projektionsfläche für Literaten und Künstler gleichermaßen. Die Beiträge des Bandes eröffnen im Dialog zwischen Literaturwissenschaft und Kunstgeschichte neue Perspektiven auf zentrale Aspekte von Leben und Werk Petrarca's und seine Bedeutung als Ausstrahlungsphänomen der europäischen Kulturgeschichte.

Schulbuch und religiöse Vielfalt Zrinka Stimac, Riem Spielhaus, 2018-10 Wie wird Religion in Bildung und Schulbüchern präsentiert? Religionsbezogene Analysen in Geschichts-, Ethik und Religionsschulbüchern unterschiedlicher Länder ergeben hinsichtlich der Konstruktion religiöser Vielfalt ein disparates Bild. Deutlich wird allerdings, dass alle Schulfächer im Hinblick auf religiöse und weltanschauliche Vielfalt vor ähnlichen Herausforderungen stehen. Eine Reihe von Beiträgen zeigt, dass Religionen in Bildungsmedien bisher nicht in ihren Wandlungen in den Blick genommen werden und die Grenzziehung zwischen Religion und »Nicht-Religion« unterbestimmt bleibt. Klar wird auch, dass die Debatte um den angemessenen Bildungszugang zu Religion in demokratischen Gesellschaften wieder an Dynamik gewonnen hat.

Die Melodie des Abschieds Sylvia Zwettler-Otte, 2006 Trennungsangst, die den Menschen von der Geburt bis zum Tod begleitet und unser Erleben von Verlust, aber auch von Bindung bestimmt, spielt in der normalen Entwicklung ebenso wie im

pathologischen Bereich eine wesentliche Rolle. Durch manifeste und latente Formen der Trennungsangst versuchen wir, dem Trennungsschmerz auszuweichen oder über ihn zu triumphieren. Diese Studie zeigt Reaktionen von Menschen auf Trennung und deren Schicksale. Die Reaktionen reichen von Flucht und Verleugnung über Depression, narzisstischen Ruckzug, psychosomatische und andere Symptome bis hin zu künstlerischen Bewältigungsversuchen und der Entwicklung der Fähigkeit zu trauern und alleine zu sein.

Historicism and Fascism in Modern Italy David D. Roberts, 2007-10-27 During the early decades of the twentieth century, Italy produced distinctive innovations in both the intellectual and political realms. On the one hand, Benedetto Croce (1866-1952) and Giovanni Gentile (1875-1944) spearheaded a radical rethinking of historicism and philosophical idealism that significantly reoriented Italian culture. On the other hand, the period witnessed the first rumblings of fascism. Assuming opposite sides, Gentile became the semi-official philosopher of fascism while Croce argued for a renewed liberalism based on 'absolute' historicism. In *Historicism and Fascism in Modern Italy*, David D. Roberts uses the ideological conflict between Croce and Gentile as a basis for a wider discussion of the interplay between politics and ideas in Italy during the early-twentieth century. Roberts examines the connection between fascism and the modern Italian intellectual tradition, arguing that the relationship not only deepens our understanding of fascism and liberalism but also illuminates ongoing dangers and possibilities in the wider Western world. This set of twelve essays by one of the leading scholars in the field represents an authoritative view of the modern Italian intellectual tradition, its relationship with fascism, and its enduring implications for history, politics, and culture in Italy and beyond.

The need for a new book on Greek colonization arose to analyse this phenomenon as a long-term process in a wide

geographic area. The events related to individual cities and regions, although geographically very distant from each other, are linked through an articulated network of material and immaterial relations and have to be considered as part of a broader mobility process in a Mediterranean perspective. The intention of Comparing Greek Colonies is to bring geographically and culturally distant regions such as Southern Italy/Sicily and the Black Sea, closer together, not merely to find similarities and differences, but to broaden the scholars' perspective and overcome existing, generalizing, and biased models, that are often rooted in local scientific traditions. The proceedings of the international conference Comparing Greek Colonies. Mobility and Settlement Consolidation from Southern Italy to the Black Sea (8th - 6th century BC), 7.-9.11.2018 in Rome, are structured around three core topics (economic system; relationships with the indigenous populations; social and territorial systems) that constitute the cornerstones of the political formation of the polis in the Archaic period and for its development during the Classical and Hellenistic Ages.
